



MINUTES OF THE AGM HELD ON 25TH DECEMBER, 2014

- Annual General Meeting of the Central Board of Revenue Employees Cooperative Housing Society (CBRECHS), was held on Thursday, 25th December, 2014 at site of CBR Town Phase-II, Kot Kolian, Tehsil & District, Rawalpindi. The meeting was attended by more than 1500 members. The members of Managing Committee attended the meeting including Mr. Altaf Ahmad Bhat, President, Mr. Zulfigar Ali, Vice-President, Ch. Nazir Ahmad, Secretary, Mr. Akhlaq Masood Sandhu, Finance Secretary, Mr. Muhammad Nadeem Khan, Executive Member (via video streaming). Mr. Shabir Ahmad, Executive Member, Mr. Muhammad Zameer Chaudhry, Executive Member, Mr. Muhammad Farooq, Executive Member & Mr. Shahzad Wasti, Executive Member along with staff of the society. The Circle Registrar and Assistant Circle Registrar, Cooperative Societies Department, Islamabad were present in the meeting.
- The meeting started just in time at 11:00 a.m with the permission of the President.
- Ch. Nazir Ahmed, Secretary of the society invited Molana Basit, for recitation of the Holy Quran. After the recitation he invited Mr. Asghar Wariach for reading Naat.

Welcome Address By The Secretary

Ch. Nazir Ahmad, the Secretary of the society announced the formal beginning



He informed the house that "after the resignation and disqualification of the elected President of the society, I and my team with the consultation of Mr. Faheem Ul Hag Khan. Chief Patron, Mr. Ishtiaq Ahmad Bhat, Co-Patron, Mr. Saleem Khan, Mr. Ghulam Shabir, Mr. Muttaqi Siddique and Mr. Khalid Qureshi and other associates decided to





co-opt Mr. Altaf Ahmed Bhat as President of the society and Mr. Shahzad Wasti as executive member of the society. so that the business of the society could be run in a better way. The members clapped, applauded and endorsed the selection of the President and the Executive Member. He thanked the members for endorsement of the decision of the secretary as well as his team. He said that the decision would be beneficial for the members of the society. He announced that approval for further extension of phase-II upto 5000 Kanal has been solicited from the Registrar Cooperative Societies, Islamabad. He further announced that launching of CBRECHS affiliated projects as well as projects on sharing basis in Karachi and Lahore, has been approved by the Registrar Cooperative Societies, Islamabad. The members clapped in appreciation of the achievements and decisions.

He paused his address by saying that final announcements will be made by the President of the society. Thereafter he called Mr. Khalid Qureshi, Project Coordinator to take responsibility as stage secretary of the meeting because he had to record the proceedings and minutes of the meeting.

Oath by MC Members

- Stage secretary invited Mr. Ghulam Nabi Nosheri for taking Oath from all MC members and senior staff members of the society. The president Mr. Altaf Ahmad Bhat and all Members of managing committee along with senior staff members took the oath in front of the house.
- take this oath that I will be loyal to the society. I will abide by all rules and regulations of the society and I will




faithfully utilize all my efforts for the betterment and benefits of the members. May Allah help us in fulfillment of this oath. May Allah be with us and support us all."

Opening Address By The President

- Mr. Altaf Ahmad Bhat, the President of the society commenced his address by reciting verses of the Holy Quran.
- The President welcomed and thanked all members of the society, FBR employees, residents of Phase-I of the society, land lords, business community for joining the occasion of AGM. He told the house that it was announced in the previous AGM held

on 25th May, 2013 to hold the next AGM at Phase-II. He said that "we promised to turn that dream into reality which the members had been seeing from last 18 years". He said that "today we have turned that dream into reality as we have unexpectedly held the AGM at Phase-II". He also emphasized on elimination of division between Phase-I and Phase-II members. He told the house that Resident.







Welfare Association of Phase-I is hosting the AGM-2014 held at Phase-II. The purpose of making them host is to eliminate the differentiation between Phase-II and Phase-I members, so that when AGM is being held at Phase-II then Phase-I members are host of the meeting and when AGM will be held at Phase-I then Phase-II members will be the host of the meeting.

He informed the house that as per Cooperative Societies Act and Byelaws, in a Managing Committee of 9 members, if some members resign then 5 or more remaining managing committee members can co-opt the outgoing members. After the co-opting the members the minutes of MC meeting are sent to the Registrar, Cooperative Societies. Same procedure was adopted for cooption and was submitted to the office of the Registrar Cooperative Societies Department, Islamabad for approval which was approved as notification was displayed on multi media as new notification. The President thanked Mr. Faheem Ul Hag Khan, Chief Patron, Mr. Ishtiag Ahmad Bhat, Co-Patron, Ch. Nazir Ahmad, Secretary and the MC members for inviting him again and co-opting as President. He assured to fulfill his responsibilities as per oath taken. He told the house about approval of extension of phase-II upto 5000 Kanal and said that all members can now be adjusted. He offered fatihah for the martyrs of the Peshawar School incident and Dua for deceased employees and other persons related to the society. The Presidents instructed the staff to distribute question sheets to the members desiring to ask any question. The President told the members that they can ask any question through question sheets which will be answered by the President. Thereafter, the President delivered phase-wise briefing to the members with multi-media projector.

Phase-I Briefing

- 12. Main point of phase-I briefing were as follows:-
- Members were briefed about the completion of pending electricity works.
- Allocation of about 10 Kanals grave yard and purchase of further 10 Kanals of land for grave yard in future.
- Completion of Overhead/Underground Tanks with storage of up to 200,000 gallons. Installation of additional tube wells and abundance of water supply in Phase-I.
- Development of green areas and completion of suigas works.
- Construction of Raazi Hospital by Islamic Circle of North America (ICNA).
- Construction of 3 Masjids and inauguration of 4th Masjid in near future. In addition allocation of plot for 5th Masjid.
- Passage from Bahria Town.
- Construction of Head Office at Phase-I has been started.
- Installation of two water filtration plants.

Phase-II Briefing


Currently Phase-II master plan is for 1600 Kanals of land. Major pocket areas and right of way have been purchased in 1600 Kanals of land through Mr. Abdul Qayyum, land provider of the society which is appreciable.








- Link Road to Motorway will be developed through which phase-II will be linked with Motorway soon.
- Right of Way Agreement: Rs.260 Million were demanded Foreign Office Employees Cooperative Housing Society. However the management negotiated their demand and finalized the ROW payment at Rs. 70 Million Only. Rs. 20 Million have already been paid and remaining amount of Rs. 50 Million will be paid over a period of two years. Construction of main gate will be started soon.
- Time frame of Phase-II Development: The President reminded the housed that in the year 2012 the management promised the members to develop Phase-II project in 3 years. The President reconfirmed the promise and announced that by the month of December, 2015 possession of majority of Phase-II blocks will be handed over to the members.





boulevard road has been build keeping in view the future requirements.

- Electricity approval has been obtained and execution will be started soon
- Approval of Sui gas is under process.
- CBR Town Phase-II has been approved by RDA as part of RDA-Vista housing scheme.
- Electricity infrastructure will be underground in phase-II including HT.







Jamia Masjid Aljabbar will be constructed by Aljabbar Foundation on their own funding at 5 kanals plot in Phase-II







- Sewerage and storm water drains are under progress.
- After phase-wise briefing the President received written question from the members, some common questions were answered as follows:-
- i. The Management Committee has purchased approximately 1000 Kanals of land (Including Right of way and pockets) in Phase-II during its previous tenure; hence almost all the members who have paid their cost of land will be adjusted in the purchased land subject to clearance of development charges. The society can be extended up to 5000 kanals subject to cooperation of members in timely payment of dues.
- ii. The society has 8500 members approximately in total out of which about 1700 members have been allotted plots in phase-I and about 1650 members have been allotted plots in Phase-II. Approximately 1200 members who have paid their cost of land will be accommodated in newly purchased land and another piece of land of 5000 Kanals will be purchased in near future to accommodate the registered members and new applicants.





- iii. The development works were carried out on labor rates basis. The development works have been carried out according to development charges approved in year 2007. Actual costs have increased twice from the year 2007 level. Therefore, development charges will now be enhanced and fixed at Rs.2,000/- per square yard.
- iv. For remaining members Cost of Land will be charged according to future rates in the agreements for purchase of further land at Phase-II at the rate of Rs. 4,000/- per square yard.
- v. The members who have paid partial payments of COL will be calculated at the rate of Rs. 1500 per square yard (cost of land) and remaining square yards would be charged as per new rates announced. If any member has paid Cost of development his dues will be calculated at the rate of 1600 per square yard and remaining area of plot will be charged as per new rates.
- 14. The President informed the house that about Rs. 400 Million have been spent on development of Phase-II and about Rs. 274 Million have been spent on Development of Phase-I by the management since the start of their previous tenure (16th May, 2011) up to 24th December, 2014. He told the house that Rs. 43 Million have been paid for clearance of Pocket areas and total amount of Rs. 665 million have been paid for procurement of land in phase-II by the management since the start of their previous tenure





(16th May, 2011) up to December, 2014. Similarly an amount of Rs. 27.5 Million has been paid for procurement of land from 16th May, 2011 up to 24th December, 2014 in phase-I. He told the house that these figures have been calculated by newly appointed Director Finance, Mr. Sami Ullah. He said that in future cost of land for members will be increased according to agreements for purchase of land. He told the members that Rs.70 Million to be paid for Right of Way will be collected from the members on proportionate basis. The house endorsed the decision taken by the management committee time to time.

 The stage Secretary invited the honorable members, senior officers of FBR and residents for expression of their valuable views.

Mr. Abid Riaz Oureshi said that when he started construction of his house in B Block Phase-I, development works were under process and water was not available at that time. Thereafter, in the tenure of Mr. Altaf Ahmed Bhat, development works were expedited. He also thanked Mr. Altaf Ahmad Bhat for relocating the masjid at Block-B to a better location



Mr. Anwar Soleri

17. Mr. Anwar Soleri started his speech with his historical zeal and zest. He emphasized that all members of the society should be equal irrespective of the departmental



background. Mr. Altaf Ahmad Bhat is continuing the progress on similar patterns started by Mr. Faheem ul Haq.

Mr. Bukhtar Muhammad Reprsenting FBR

18. Mr. Bukhtar said that on behalf of all employees of FBR he is pleased to see the pace of development works at phase-II. He thanked the management for offering discounted plots for Class-IV FBR Members. He asked for continuing the discount policy for Class-IV members.



Ch. Khalil Ahmed

19. Ch. Khalil Ahmed thanked Mr. Altaf Ahmed Bhat, President of the society and Ch. Nazir Ahmed, Secretary of the society and the Members of the MC on behalf of Resident Welfare Association of Phase-I.



Ch. Bashir Ahmad Arien

20. Ch. Bashir Ahmed congratulated Mr. Altaf Ahmad Bhat for being co-opted as President and Mr. Shazad Wasti for being co-opted as Executive Member. Mr. Altaf Ahmad Bhat and other MC member approved the 30 Kanals land which was required for school/college. He said that 20



Kanals College and 10 Kanals School at Phase-II are in pipeline in yearly budget of 2015-2016.



Mr. Shahzad Wasti

21. Mr. Shahzad Wasti thanked all members for coming to the AGM, specially members from Karachi, Lahore and Peshawar. He urged FBR employees to obtain membership of the society.



Mr. Faheem UI Haq Khan (Chief Patron of Cbrechs)

22. Mr. Faheem Ul Haq Khan said that he joined the society in acceptance of a challenge. He said that an AGM of the society was held on 19th June, 2005. At that time members were seeking refunds of their deposits and there was nil value of membership in the market (Phase-I and



CENTRAL BOARD OF REVENUE Employees Cooperative Housing Society (Regd) Islamabad Phase-II). In that AGM Mr. Anwer Soleri, member of the society, challenged the house that is there no officer in FBR who can come and run the society. He said that he accepted the challenge and during his tenure, from year 2006 to year 2009, the society was passed over to his successors in a much better condition than what he received from his predecessors. He said that in June 2005 total number of members participating in AGM was less than 80. Now in year 2014, after 9 years number of members have increased immensely and increased participation is a gesture of satisfaction.

- 23. He said that since year 2011 he had always supported the MC. He said my support is with Mr. Altaf Ahmad Bhat and my job is to provide strategic guidance only. However, there is possibility of human error and he will always welcome positive suggestions and constructive criticism for overall betterment.
- 24. In his speech Mr. Faheem Ul Haq Khan proposed that an audit committee be constituted, comprising of old members. Management Committee's work and decisions will be over sighted by the audit committee. He informed the house that Cooperative Laws allow its constitution and defines its terms of performance. All members who have any reservations in respect of functional or operational areas can give their names for inclusion in the audit committee.
- 25. Mr. Faheem Ul Haq suggested that quota for Class-IV, FBR employees should be unlimited. The payment schedule for Class-IV members should be concessional. Class-IV members will not be allowed to sell their plots. He also informed that some officers of FBR have asked for problems in payment of dues. In this regard he suggested that some committee should be constituted for important decisions/approvals so that decisions can be taken timely without having to wait for the next AGM. Such committee will decide on issues of allotment/relaxations, payment issues and other important matters.
- Mr. Faheem Ul Haq said that for fair comparison, CBRECHS should be compared with its neighboring societies. He said that the market value of CBRECHS is comparatively better



than the neighboring societies. He said that Management Committee is trustee of wealth of members, therefore, management should fulfill the expectations of members. In concluding his address, Mr. Faheem Ul Haq Khan said that he is always available for accountability and always remained present in the AGM 2006, 2007, SGM 2009, AGM 2010. SGM 2011 and AGM 2013.

He said that the remarkable achievements of this management committee not only led to completion of the project but also induced investors and members. A record value addition was achieved besides land mark tasks of approvals etc. accomplished.

Mr. Ishtiaq Ahmed Bhat (Co Patron)

77. Mr. Ishitaq Ahmad Bhat requested Mr. Altaf Ahmad Bhat, President and Ch. Nazir Ahmad, the secretary of the society that members should be given some good news in the AGM so that members go back happily to their homes after the AGM.



He thanked all members who attended AGM held at Phase-II. He said that it was unimaginable that AGM will be held at Phase-II. He congratulated Mr. Altaf Ahmad Bhat, the President and Ch. Nazir Ahmad, the secretary for purchase of land in Phase-II and obtaining "Right of Way" from Foreign Office Employees Cooperative Housing Society after 20 years.

Concluding Address By The President

 The President thanked Circle Registrar, Cooperative Societies Department, Islamabad and other guests for coming to the AGM.



- The President answered different questions of members:
- Answering the questions put by Mr. Imtiaz Khan from Block-B, Phase-I the President said that MC has devised new strategy for completion of Phase-I Works.
- ii. Answering a question the President said that SGM will be held in April, 2015 for balloting of Phase-II plots. It is a routine matter in other cooperative societies that long litigations are faced by members related to allotment of plots. Therefore, in CBRECHS, as per previous policy approved by the AGM on 25th May, 2013 plots will only be allotted to those members who have paid Cost of Land and Cost of Development in full.
- Answering a question the President said that possession of blocks A, B, C, D & E of Phase-II will be handed over to members uptill December, 2015.
- iv. Answering a question the President said that the society had advertised that after 20th December, 2014 New Rates will be applicable for Cost of Land and Development.
- Answering a question the President said that discount of up to Rs. 400,000/- for orphans of widows will be continued in future.
- vi. Answering a question the President said that electricity

- works of Phase-I will be completed through separate committee headed by Mr. Zulfiqar Ali, Vice-President of the society and assisted by Mr. Akhalq Masood Sandhu and Muhammad Farooq Khan. All matters related to electricity matters will be supervised by the committee.
- vii. Answering a question the President said that for those members who are financially weak, installment facility is available, however plots will only be allotted after full payment of cost of land and cost of development.
- viii. Answering a question the President said that Ch. Bashir had always beem working for Educational facilities in Phase-I. An education committee headed by Ch. Bashir Ahmed Arien and assisted by Syed Shakil Ahmed and Ch. Khalil Ahmed has been formed for the promotion of Educational facilities in Phase-I and Phase-II.
- ix. Answering a question the President said that HT works at Phase I will be executed underground after availability of funds. Proposal will be submitted for approval in concluding address.
- x. Answering a question the President said that membership will be reopened in the future through advertisement subject to availability of land.
- xi. Answering a question the President said that the problem of River blockage at phase-I will be resolved soon. He requested Malik Ishrat, local land lord for his support for starting works at River side in Phase I.
- 3. Answering a guestion the President informed that for

- class-IV members the society will allot plots at 50% payment of Cost of Land and Cost of Development, according to old rate or new rate whichever is applicable to class-IV members.
- 4. The president said that it was decided by this management to take Mr. Bashir Ahmed as Ex-Officio member of the Management Committee. However, Ex-Officio member have been banned as per rules of Cooperative Societies Department, Islamabad. Therefore Mr. Bashir Ahmed will be technical member of the Management Committee for promotion of Education, health and other departmental approvals.
- 5. Three member Audit Committee will be constituted on the basis of volunteer members. However, such members should have know how of the audit works. All interested members can notify their names from which three members will be selected through balloting. Thereafter the approval of committee will be sought from the Circle Registrar, Cooperative Societies Department, Islamabad.
- Another supervisory think-tank committee will be constituted which will help managing committee at different corners.
- 7. On demand of the members the last date for old rates which was 20th December, 2014 is further extended till 31 December, 2014. After 31 December, 2014 cost of land will be Rs. 4000 per square yard and cost of development will be Rs. 2000 per square yard. The cheques and payorders which will be received till 31st December, 2014 shall be considered on 1500 per square yard COL and 1600 per





- square yard development charges.
- The President thanked Circle Registrar for approval of attention of commercial plots in Phase II. The President said that commercial plots will be sold on the pattern of Defense Housing Authority. Commercial plots will first be offered to the members of the society at the rate of Rs.5.000,000/- per plot sizing 155 Sg yard, the rate determined by the consultant of the society. The area of commercial plots is 6 marla and plots are located on 300 feet and 400 feet main roads. For members down payment 40 % and remaining amount will be paid in one year's installments. Members who will pay in lumpsum cash will be allotted commercial plots at the rate of Rs. 3,950,000/- per plot. If the existing members of the society are unable to book all the plots in one month up till 31st January, 2015, then plots will be auctioned through open bidding to business community/investors and starting bid will be Rs.3.950.000/- minimum.

- The President presented the proposal for remaining works at Phase-I for sewerage treatment plant, underground HT, boundary wall, street lights and beautification etc., Rs. 300 per square yard will be charged from Phase-I members. The charges for commercial plots will be Rs.900 per square yard. The remaining works of Phase-I will be completed from these charges. Said dues will be collected before or at the time of transfer and construction of house. Residents will be given facility of installments.
- Affiliation/joint venture residential and farming projects will be launched by the society, namely "CBR Residencia"

- and CBR Farming Enclave in Rawalpindi/Islamabad and further projects at Lahore and Karachi for which approval has been granted by the Registrar, Cooperative Societies Department, Islamabad.
- After the President's speech Audited Accounts for the Financial Year 2012-2013 and financial year 2013-2014 were presented before the house (Annexed at the end of minutes). In addition projected Annual Budget for the Financial Year 2014-2015 was also presented before the house. The house unanimously approved the audited accounts of the preceding periods and the budget for the financial year 2014-2015.
